- **Vendor to provide own commercial grade tent**
- **Vendors are responsible for all set up and clean-up of their booth space, and their immediate surrounding area**
- **Weights are required to secure booth (Minimum 20lbs on each corner)**
- **No vendor will be permitted to erect signs or display products obstructing the view of other vendors, also it is prohibited to distribute promotional materials outside the limits of your booth**
- **Vendor must provide own lights**
- **We are not accepting Food vendors**
- **Pre-Packaged food vendors will be limited with County of Ventura Permit**

### Terms and Agreement

**Passes** – Vendors will receive (2) one day passes per 10-foot booth and (3) one day passes per 20 foot booth.

**Refunds** – Booth fee is Non-refundable. Fees are refundable if the Throwdown LLC receives a written request for cancellation no later than June 1, 2026. After this date, The Throwdown LLC retains all fees.

**Taxes** – Exhibitors are responsible for all taxes and fees associated with their activities at the Throwdown LLC. This includes, but is not limited to license fees, and Federal, state and local taxes if any.

**Release/Hold Harmless** – The Exhibitor hereby agrees to indemnify and hold harmless the Throwdown Productions LLC and its officers, directors, employees and agents from any financial liability or obligation incurred by the Exhibitor or from any injury or damage to the person or property of others which any exhibitor causes or contributes to causing while participating in any way in the Throwdown LLC. The Exhibitor, by signing this Agreement releases The Throwdown Productions LLC, damage, cost, accident, delay, irregularity or expense arising out of or in any way connected with the performance or operation of The Throwdown Productions LLC.

**Events Beyond The Throwdown’s Control-** The Throwdown Productions LLC shall not be responsible for any events beyond its control, such as, without limitation, acts of God, acts of war, terrorism, strikes, or governmental restrictions or for acts of omissions of persons, entities, or companies not controlled by it, such as, without limitation, police officials, government entities, bus companies, railways and hotels. The Throwdown Productions LLC and its officers, directors, employees and agents are hereby released from all claims arising out of such events, acts and omissions.

**Compliance with The Throwdown’s Requirements** - Absolutely **NO OUTSIDE ALCOHOL MAY BE BROUGHT INTO BOOTHS**. Booths must look professional and organized. We will provide a dumpster for you to put your trash. All exhibitors must conform to the rules and requirements of The Throwdown as described in this application and/or as supplied, amended, or supplemented at the Throwdown event. Failure to comply with the rules and requirements of the Throwdown, including failure to open or close the booth on time, could be the cause for expulsion from the Throwdown event. Any such expulsion decision is made at the sole discretion of The Throwdown Productions LLC. Any questions regarding the rules and regulations should be made to the Committee at the time of application or prior to The Throwdown event. All applicants/exhibitors agree to hold The Throwdown Productions LLC and its officers, directors, employees and agents harmless from any loss whatsoever as a result of any expulsion from The Throwdown.

**Security** - There will be 24-hour security provided. There will be a pod that is lockable for vendors to store their merchandise in at night for extra security. The Throwdown Productions LLC is not responsible for lost or stolen products. We suggest you secure your tents at night with some type of screen to cover your products. This is the full and final agreement of the parties, no other agreements be they oral, written, prior to contemporaneous, shall be honored by The Throwdown Productions LLC.
